APPOINTMENT OF MEMBERS OF THE LABOUR ADVISORY BOARD  
NOTICE, 2000  
(Under section 23)

In exercise of the powers conferred by section 23 of the Industrial Relations Act, 2000 the Minister for Enterprise and Employment makes the following Notice -

*Citation and commencement.*

1. This Notice may be cited as the Appointment of Members of the Labour Advisory Board Notice, 2000 and shall come into force on the 25<sup>th</sup> August, 2000.

*Establishment and Composition of the Board.*
