APPOINTMENT OF EXAMINERS AND MAKING OF CERTAIN RULES IN REGARD  
TO THE EXAMINATIONS (AMENDMENT) REGULATIONS, 2000  
(Under section 33(3) and (4))

*Citation*

1. These Regulations may be cited as the Appointment of Examiners and Making of Certain Rules in Regard to the Examinations (Amendment) Regulations, 2000 and shall be read as one with the Appointment of Examiners and Making of Certain Rules in Regard to the Examinations Regulations, 1967 (hereinafter referred to as the "principal Regulations").

*Amendment of Regulation 5*

1. Regulation 5 of the principal Regulations is amended-

(a) in sub-regulation (1) -

- (i) by replacing the words "twenty Emalangeni and the figure "(E20)" with the words "fifty Emalangeni" and the figure "(E50)";
- (ii) deleting the proviso thereto.

(b) by replacing sub-rule (2) with the following new sub-rule -

- "(2) Any examiner shall be entitled to be paid the sum of five hundred Emalangeni (E500) in respect of any such examination."

THE EMKHUZWENI HEALTH CENTRE (HANDOVER) COMMITTEE, 2000  
(Under section 3)

In exercise of the powers conferred by section 3 of the Commission of Enquiry Act, 1963, I hereby issue the following Notice -

*Citation and commencement.*

1. This Notice may be cited as the Emkhuzweni Health Centre, (Handover) Committee Notice, 2000 and shall be deemed to have come into force on the 10<sup>th</sup> January, 2000.

*Establishment and Composition of Committee.*

2. (1) There is hereby established a Committee to be known as the Emkhuzweni Health Centre (Handover) Committee.

(2) The Committee shall consist of the following members -

(3) The quorum of the Committee shall be six members including the Chairperson.

*Functions of the Committee.*

3. (1) The Commission shall examine and enquire into the activities of the Emkhuzweni Health Centre, and shall without prejudice to the generality of the foregoing examine and enquire into -

- (a) the legal, financial, personnel, administrative and social implications of the handover of the Emkhuzweni Health Centre to Government;

- (b) financial management status of the Emkhuzweni Health Centre;
- (c) inventory of the workforce and its status with respect to qualifications and conditions of service;
- (d) inventories, conditions and value of all assets and consumables;
- (e) the official boundaries of the property to be handed over to Government; and
- (f) the role of the community and the local church in the running of the Emkhuzweni Health Centre.

*Power.*

4. The Committee has power to -

- (1) facilitate consensus building among all stakeholders on the conditions of the handover.
- (2) call for and review any documents and records it may deem necessary or relevant to the enquiry.

*Report.*

5. The Commission shall, after making appropriate findings, submit -

- (1) an interim report containing appropriate recommendations on any matter which is the subject of the enquiry and which require immediate action and any other information it deems urgent.
- (2) a final report which shall be presented not later than the 31st March, 2000 or on such later date as the Minister may, in writing, permit.

*Meetings.*

6. The enquiry shall be held at the Emkhuzweni Health Centre or such other place and at such times as the Chairperson may determine.

*Enquiry to be held in public.*

7. Unless the circumstances otherwise require, the enquiry shall be held in public.

*Allowances.*

8. The members of the Committee shall be paid such allowances as the Minister may determine.
