LEGAL NOTICE NO. 7 OF 2001**ANIMAL DISEASE ACT, 1965
(Act No. 7 of 1965)****THE STOCK DISEASES (FOOT AND MOUTH DISEASE NO. 3) REGULATIONS, 2001
(Under Section 3)**

In exercise of the powers conferred by Section 3 of the Animal Diseases Act 1965, the Minister for Agriculture and Cooperatives hereby makes the following Regulations:

Citation and Commencement

1. These Regulations may be cited as the Stock Diseases (Foot and Mouth Disease No. 3) Regulations 2001 and shall be deemed to have come into force on the 20th December 2000.

Declaration of Foot and Mouth Disease Guard Areas

2. The areas falling under the dip tank areas specified in the First and Second Schedules to this Notice are hereby declared Foot and Mouth Disease Infected Area and Foot and Mouth Disease Surveillance Area respectively.

Prohibition of Movement of Animals and Animal Products

3. The movement of animals and animal products out of the Infected Area is hereby prohibited. Any movement of animals and animal products out of the Guard Area is restricted. Movement of such into the Infected and Surveillance Areas other than in accordance with the written permission of the Director of Veterinary and Livestock Services or his appointed representatives is prohibited.

Movement of Persons, Vehicles and Containers

4. Vehicles, containers and people moving in and out of the Infected and Guard Areas may be subjected to the necessary searches and sanitary measures prescribed under these regulations.

Presentation of Susceptible Animals for Examination and Testing

5. Owners of all susceptible animals in the Infected and Guard Areas shall present the animals to the dip tank areas specified in Schedule 1 and 2 for examination testing and inoculation as is necessary and are called upon to do so.

Destruction of Infected Animals

6. All susceptible animals found to be infected or reacting positive for the disease agent in the Infected and Guard Areas shall be destroyed by the Veterinary, Police and Defence Force Personnel.

Offences and Penalties

7. Any person who contravenes the provisions or fails to comply with the requirements of the regulations commits an offence and shall be liable, on conviction, to a fine not exceeding Six Hundred Emalangeni (E600.00) or imprisonment to a term not exceeding two years or to both.

LEGAL NOTICE NO. 8 OF 2001

ANIMAL DISEASE ACT, 1965
(Act No. 7 of 1965)

THE STOCK DISEASES (FOOT AND MOUTH DISEASE NO. 4)
REGULATIONS, 2001

In exercise of the powers conferred by section 3 of the Animal Disease Act, 1965 the Minister for Agriculture and Co-operatives makes the following Regulations -

Citation and Commencement

1. These Regulations may be cited as Stock Diseases (Foot and Mouth Disease No. 4) Regulations, 2001 and shall be deemed to have come into force on 23rd December, 2000.

Revocation of Legal Notice No. 166 of 2000

2. Legal Notice No. 166 of 2000 is hereby revoked.
