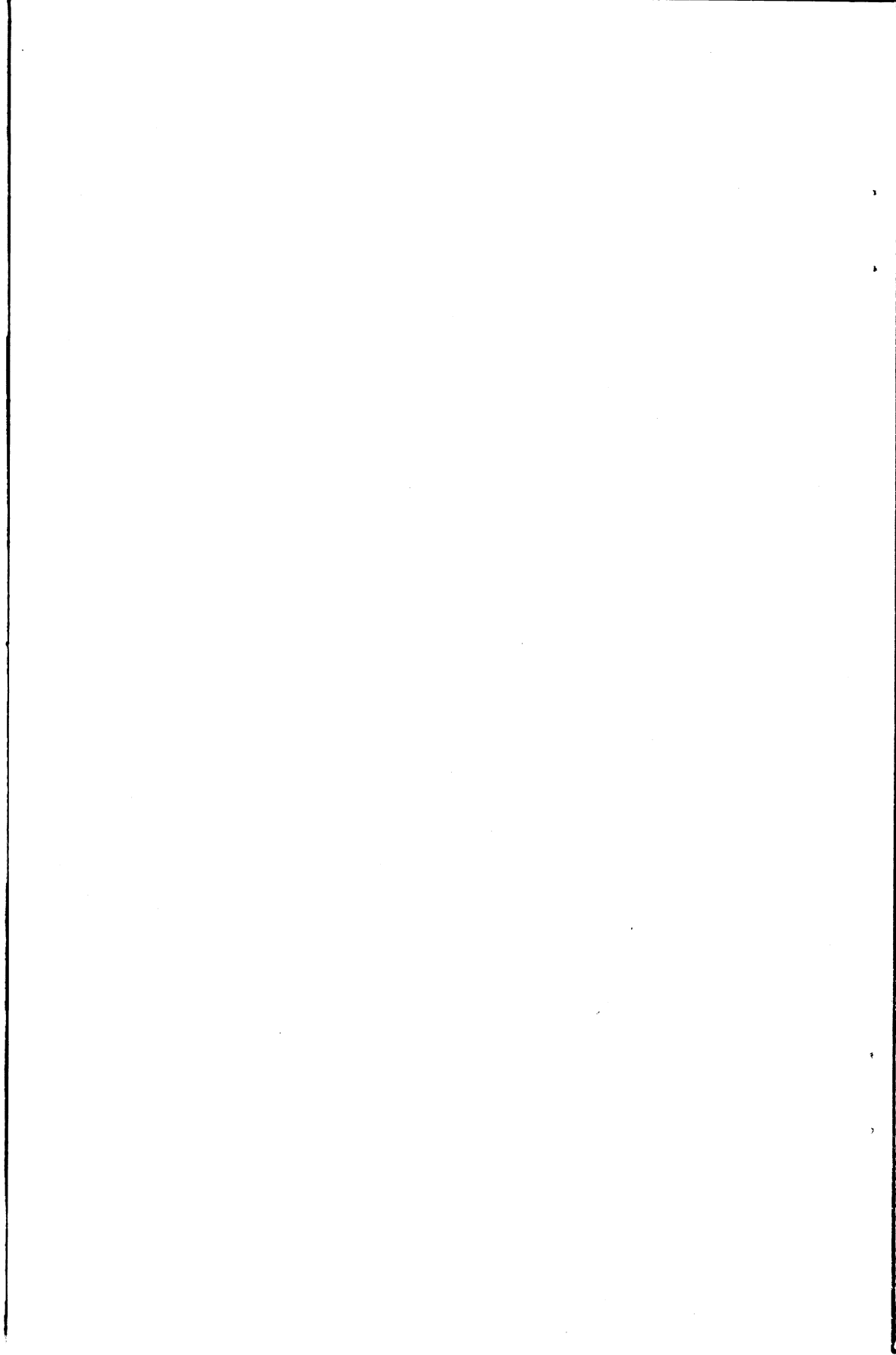

### THE CROWN LANDS DISPOSAL ACT, 1911 (Act No. 13 of 1911)

### DECLARATION OF MSUNDUZA TOWNSHIP (EXTENSION NO. 4) REGULATIONS, 2002 (Under Section 12)

In exercise of the powers conferred by Section 12 of the Crown Lands Disposal Act, 1911, the Minister for Housing and Urban Development hereby makes the following regulations.

#### **Arrangement of Regulations**

Regulations:-

1. Citation and Commencement;
2. Interpretation;
3. Establishment of Township and alteration of General Plan;
4. Conditions of Sale;
5. Use of lots;
6. Dwelling house; and
7. Subdivision.

#### **PART I - GENERAL**

##### ***Citation and Commencement.***

- 1) These regulations may be cited as the Msunduzi Township Extension No. 4 and shall come into force on the date of publication in the gazette.

##### ***Interpretation.***

- 2) In these regulations:-

“Lot” means a lot in the Township;

“the Minister” means the Minister for Housing and Urban Development;

“the Township” means the Msunduzi Township Extension No.4 established by regulation 3.

#### **PART II - ESTABLISHMENT OF TOWNSHIP**

##### ***Establishment of Township and alteration of the General plan.***

- 3) The following land is hereby proclaimed and established as a Township:-

CERTAIN : Farm No. 1298 situate in the Hhohho District, Swaziland.

MEASURING : 143,1933 (one four three comma one nine three three) hectares.

HELD : (a) By the Crown under Certificate of Consolidated Title No. 755/2001 dated the 31<sup>st</sup> December, 2001, comprising of 1828 (one eight two eight) Lots Numbered 198 - 2025 and roads and lanes as will more fully appear from General Plan S.G No. S.47/1999 approved by the Surveyor-General on the 17th November, 1999.

(b) The Surveyor-General shall alter the General Plan so as to indicate the name and Lot Numbers assigned by these Regulations of the Township and endorse the General Plan S.G. No. S.47/1999 accordingly.

***Endorsement of Title Deeds and opening of Register.***

4) The Registrar of Deeds shall:-

- (a) Make necessary endorsement on the relevant title deeds, and
- (b) Open the necessary register in connection with the Township.

***Conditions of Sale.***

5) The Conditions of Sale of lots in the Township shall be those contained in a Government Grant.

***Use of Lots.***

6) The lots in the Township shall be used only for residential purposes or for such other purposes as the Local Authority may approve.

***Dwelling houses.***

7) Not more than one dwelling house with the necessary out-building shall be erected on each lot.

***Subdivision.***

8) Not lot shall be subdivided without the express written permission of the Minister.

(Under Section 3)

In exercise of the powers conferred by section 3 of the Commissions of Enquiry Act, 1963, the Minister for Enterprise and Employment hereby issues the following Notice:

***Citation and Commencement***

1. This Notice may be cited as the Appointment of the SAPPI Outsourcing Committee Notice, 2002 and shall be deemed to have come into force on the 1st February 2002.

***Establishment and Composition of Committee***

2. There is established a Committee to be known as the SAPPI Outsourcing Committee (herein referred to as "the Committee") which shall be composed of the following persons -

***Objective of the Committee***

3. The objective of the Committee is to facilitate the conclusion and implementation of an outsourcing agreement between SAPPI and the employees who have recently accepted voluntary retrenchment packages, whereby SAPPI will outsource some of its business operations from the said employees and they, in turn, will set up business enterprises to undertake the outsourced operations.

***Functions of the Committee.***

4. The Committee shall perform the following functions -

- (a) assist SAPPI Management in determining the scope of the operations to be outsourced by SAPPI from the retrenched employees;
- (b) carry out an analysis of the business opportunities arising from the operations to be outsourced;



- (c) advise the parties on measures to be put in place in order to exploit these opportunities to the mutual benefit of all parties;
- (d) equip the retrenched employees to establish viable business enterprises which will undertake the operations outsourced by SAPPI through, inter alia;
  - (i) providing guidance and advice on the pre-requisites for establishing and operating a business;
  - (ii) facilitating access to finance;
  - (iii) providing technical expertise and support in the negotiation of the terms and conditions to be embodied in the outsourcing contracts between the enterprises established by the retrenched employees, on the one hand, and SAPPI on the other hand; and
- (e) hold regular meetings with all stakeholders, including representatives of the retrenched employees and SAPPI Management, to discuss issues pertaining to the objective of the Committee and to guide the parties as and when required.

***Term of office***

- 5. The term of office of the Committee shall be three months.

***Allowances***

- 6. The Committee shall be entitled to such allowances and, where applicable, re-imbursement for travelling expenses in accordance with Finance Circular No. 4 of 1998.

***Frequency of meetings***

- 7. The Committee shall meet at least once a week and as often as it may be necessary to carry out its functions.

***Quorum***

- 8. The chairperson and three members shall constitute a quorum.

***Submission of Report***

- 9. The Committee shall submit a report on its functions to the Minister every two weeks from the date of appointment and whenever so required by the Minister.

***Extension of term of appointment***

- 10. The Minister may, by Notice published in the Gazette, extend the period stated in section 4.
