LEGAL NOTICE NO. 57 OF 2002

THE SUGAR ACT, 1967
(Act No. 4 of 1967)

THE SUGAR INDUSTRY AGREEMENT (AMENDMENT) NOTICE, 2002
(Under section 3)

In exercise of the powers conferred in me by section 3 of the Sugar Act, 1967, I hereby issue the following Notice:

Citation and Commencement

1. This Notice may be cited as the Swaziland Sugar Industry Agreement (Amendment) Notice, 2002 and shall be deemed to come into force on Monday 29 April 2002.

Amendments

2. Clause 46 is amended as follows:-

(i) by deleting the Table immediately below Clause 46 (1) and replacing same with the following Table:

Season	Growers %	Millers %
2002/3	67.70	32.30
2003/4	67.90	32.10
2004/5	68.10	31.90

(ii) by deleting the current Clause 46 (5) and re-wording it as follows:-

“The percentages relating to the division of proceeds referred to in Clause 46 (1) shall take effect from the commencement of the 2002/2003 Season and shall apply for 3 (three) full seasons, that is to say until the end of the 2004/2005 Season.”

(iii) by replacing the current Clause 46 (5) (b) with the following:-

“Unless the parties specifically and unanimously agree to an earlier or later date of review, the parties shall reach agreement by 30 June 2004 on the percentages which shall apply from the end of the 2004/2005 Season”

(iv) by replacing the present Clause 46 (5) (c) with the following:-

“In the event that the parties fail to agree as provided for in Clause 46 (5) (b) within the time limits stipulated in that Clause, then such dispute shall be referred to Arbitration.”

(v) by replacing the present Clause 46 (5) (c) with the following:-

“The Arbitrator shall be appointed by Chairman of the Independent Review Committee. Notwithstanding the provisions of Clause 55, the Arbitration shall be conducted upon such terms and conditions as the Arbitrator in his sole discretion shall direct and on the basis that his written decision, which shall be final and binding upon the parties, shall be handed to the Association by no later 30 November 2004.

LEGAL NOTICE NO. 58 OF 2002

ANIMAL DISEASE ACT, 1965
(Act No. 7 of 1965)

THE STOCK DISEASES (RABIES NO. 7) REGULATIONS 2002
(Under Section 3)

In exercise of the powers conferred by Section 3 of the Animal Diseases Act, 1965 the Minister for Agriculture and Cooperatives hereby makes the following Regulations:

Citation and Commencement:

1. These Regulations may be cited as the Stock Disease (Rabies No. 7) Regulations, 2002 and shall be deemed to have come into force on 22nd April, 2002.

Declaration of Rabies Guard Areas:

2. The areas specified in the First Schedule are declared to be Rabies Guard Areas.

Isolation and Confinement of Dogs:

3. Every owner of a dog or cat in a guard area shall isolate and confine his dog or cat so as to prevent it from escaping from such guard areas and such confinement and isolation shall remain in force until further notice.

Presentation of Dogs and Cats for Vaccination:

4. A person who owns a dog or cat and lives within the area specified in the schedule to this Notice shall present his pets for inoculation at the designated vaccination centre and on the time specified in the Second Schedule.

Offence and Penalty:

5. An owner of a dog or cat who fails to comply with regulation 3 and 4 commits an offence and is liable on conviction, to a fine not exceeding E300-00 and in default of payment, to imprisonment for a period not exceeding 3 months.

Destruction of Dogs and Cats in Rabies Guard Areas:

6. (1) A Government Veterinary Officer may destroy a dog or cat in any of the Rabies guard areas if in his opinion, the dog or cat has not been confined so as to prevent it from escaping from such guard areas.

(2) In pursuance of sub-regulation (1) a Government Veterinary Officer may ask for the assistance of the Royal Swaziland Police in carrying out the provision of that sub-regulation.
