



THE APPOINTMENT OF THE REVIEW OF OPERATIONS OF THE JUDICIARY
TASK FORCE, NOTICE, 2001
(Under section 3)

In exercise of the powers conferred by section 3 of the Commissions of Enquiry Act, 1963, the Prime Minister issues the following notice -

Citation and Commencement

1. This Notice may be cited as the Appointment of the Review of Operations of The Operations of the Judiciary Task Force Notice, 2001 and shall be deemed to have come into force on the 16th April, 2002.

Establishment and appointment of members of the Task Force

2. There is established a Task Force to be known as the Review of Operations of the Judiciary Task Force (in this Notice referred to as the "Task Force") and shall consist of the following persons -

Functions of the Task Force

3. The Task Force shall -

- (a) examine salaries and conditions of service of the judiciary and Government law office;
- (b) inspect and suggest improvements to the court's infrastructure throughout the country;
- (c) review systems for using existing resources, especially management of court time, judges and magistrates, available to the judiciary;
- (d) review the standards of supervision and discipline in the judiciary and Government law office;
- (e) examine the legal provisions relating to the retirement age of judges and advise;
- (f) examine the payment's processing system of the judiciary and Government law office and consider the appointment of heads of departments as finance warrant holders;

- (g) suggest a scheme of short to medium term external technical assistance to relieve staff shortages as well as maintain present local staff and assist in the acceleration of the localisation programme;
- (h) suggest a scheme of training to enhance the skills of staff in the judiciary and Government law office;
- (i) suggest a scheme for the employment of law graduates to enhance skills and assist in the administration of justice;
- (j) suggest a scheme for a speedy conclusion of minor offences; and
- (k) make recommendations which will incorporate the accepted recommendations of recent consultancy reports.
- (l) carry out other functions and duties which are relevant to this Notice as the Prime Minister may, in writing, order the Task Force to perform;
- (m) produce and deliver to the Prime Minister a report on the operation of this Notice.

Submission of Report

4. The Task Force shall deliver the report mentioned in section 3 (m) not later than the 30th June, 2002.

Meetings

5. (1) The Task Force shall meet at a place and time as the Chairman of the Task Force may determine.

(2) The Task Force shall make rules for the regulation of its business and procedure relating to its meetings.

Allowances and Reimbursements

6. The members of the Task Force shall be entitled to sitting allowances and, where applicable, reimbursement for travelling expenses in accordance with the Finance Circular No. 4 of 1998.

Extension of Time

7. The Prime Minister may, by Notice published in the Gazette, extend the time specified under section 4.

THE IMPORT AND EXPORT OF SCHEDULED PRODUCTS REGULATIONS, 2001
(Under Section 15)THE IMPORT AND EXPORT OF SCHEDULED PRODUCTS NOTICE, 2002
(Under Regulation 7)

In exercise of the powers conferred by Regulation 7 of the Import and Export of Scheduled Products Regulations, 2001, the National Agricultural Board issues the following Notice -

Citation and Commencement

1. This Notice may be cited as the Import and Export of Scheduled Products Notice, 2002 and shall be deemed to have come into force on the 2nd May, 2002.

Imposition of Levy on Imported Scheduled Products

2. The levy due and payable on the value of imported scheduled products shall be as follows -
 - (a) Maize excluding seed maize, yellow maize and popcorn - between 1% and 4.5%
 - (b) Maize products excluding processed Poultry and animal feed - between 1% and 10.5%
 - (c) Rice - 3.5%
 - (d) Fresh fruits excluding apples, pears, peaches and banana - between 1% and 7.5%
 - (e) Apples, pears, peaches and grapes - between 1% and 4.5%
 - (f) Banana - between 6.5% and 25%
 - (g) Fresh vegetables excluding cabbages, tomatoes, potatoes and seed potatoes - between 1% and 10%
 - (h) Cabbages, tomatoes and potatoes excluding seed potatoes - between 1% and 20%
 - (i) Poultry and poultry products including live broiler birds, day old chicks and hatching eggs - between 5% and 15%
 - (j) Wheat - between 5% and 15%
 - (k) Wheaten products - between 7% and 18.5%
