CORRIGENDUM

**THE ENVIRONMENT MANAGEMENT ACT, 2002
(ACT NO. 5 OF 2002)**

The Environment Management Act, 2002 is corrected as follows:

- (a) in section 13 (4) by deleting the word "or" between "(g)" and "(h)" and substituting it with the word "and"
- (b) in section 13 (5) by adding "(e), (f) and" after the word "paragraphs" and deleting the words "and (h)" after "(g)" further, by deleting the words " , whenever the relevant position on the Board is vacant" appearing at the end of the line.
- (c) in section 13 (6) firstly by deleting the words "or persons" appearing after the word "person", secondly by deleting the word "whenever" appearing next to the word "Board" and substituting it for the word "for", thirdly by deleting the words "paragraph (i) of subsection (2) is vacant" appearing next to "in" and substituting those words with "(h)".

(Order 24 of 1964)****THE ARMS AND AMMUNITION REGULATIONS
(AMENDMENT) NOTICE, 2004
(Under Section 35)**

In exercise of the powers conferred by Section 35 of the Arms and Ammunition Act, 1964, the Prime Minister hereby issues the following Notice:-

Citation and Commencement

1. This notice may be cited as The Arms and Ammunition Regulations (Amendment) Notice, 2004 and shall be read as one with the Arms and Ammunition Regulations of 1964. The Notice shall come into force on 1st of April, 2004.
