## LEGAL NOTICE NO. 62 OF 2004

THE MEDICAL AND DENTAL PRACTITIONERS ACT, 1970  
(Act No. 3 of 1970)THE MEDICAL AND DENTAL PRACTITIONERS (AMENDMENT)  
RULES, 2004  
(Under Section 6)

In the exercise of the powers conferred by Section 6 of the Medical and Dental Practitioners Act, 1970, the Swaziland Medical and Dental Council makes the following rules -

***Citation and Commencement***

1. These Rules may be cited as the Medical and Dental Practitioners (Amendment) Rules, 2004 and shall come into force on the date of publication.

***Amendment of Rule 2***

2. Rule 2 is amended by replacing it with the following new Rule 2 -

***“Registration and annual fees***

2. (1) A person seeking to be registered in terms of the Act shall pay the following fees in the circumstances described hereunder, namely, for registration -

- (a) of each additional qualification under section 13(1)(g) of the Act, fifty Emalangeni (E50.00);
- (b) as a registered Medical or Dental practitioner, two hundred and fifty Emalangeni (E250.00), and thereafter an annual fee of two hundred Emalangeni (200.00);
- (c) as a licenced Medical or Dental practitioner, two hundred Emalangeni, (E200.00) for the first registration and two hundred Emalangeni (E200.00) for each subsequent registration following in continuous years;
- (d) on the directions of the High Court in terms of section 13 (1) (j) of the Act, the fees prescribed under paragraph (b) or (c), as the case may be, or as otherwise ordered by the High Court;
- (e) after an application made under section 13(4) of the Act, the fee prescribed under paragraph (b) or (c), as the case may be;
- (f) provisionally, under section 16 of the Act, One hundred Emalangeni, (E100.00);
- (g) of any speciality which, under any law, be recognised as a speciality, Three hundred Emalangeni (E300.00) and thereafter an annual fee of Two hundred and fifty Emalangeni (E250.00);
- (h) of interns, One hundred Emalangeni (E100.00);
- (i) of certificate of goodstanding, fifty Emalangeni (E50.00).

(2) A medical or dental practitioner from outside Swaziland who voluntarily renders his services, free of charge, to the Government of Swaziland or to any hospital in Swaziland, shall not be liable to pay fees under this rule unless the medical or dental practitioner has been, on application, registered as a medical or dental practitioner under these rules.

(3) The Swaziland Medical and Dental Council may exempt any person from the payment of the entire or any portion of fees payable under this rule.

(4) The annual fee referred to in sub-rule (1)(b) shall become payable on the 1<sup>st</sup> October of each year and shall be payable in advance."

(5) The late payment of an annual fee shall be accompanied by a fee of one hundred Emalangeni (100.00)."

***Amendment of Rule 3***

3. Rule 3 is amended by replacing it with the following new Rule 3 -

***"Fee payable for certificate of registration or licence.***

3. (1) Except as provided in sub-rule (2), no additional fee shall be payable for a certificate of registration or licence.

(2) A duplicate certificate of registration or licence may be issued on payment of a fee of five Emalangeni (E5.00)."

***Amendment of Rule 4***

4. Rule 4 is amended by replacing it with the following new Rule 4 -

***"Inspection of registers.***

4. (1) The registers kept by the Registrar under the Act may be inspected at the Ministry of Health on Mondays to Fridays between 8:00a.m. and 1:00p.m. and between 2:00p.m. and 4:30p.m.

(2) A fee of fifty Emalangeni (E50.00) shall be payable for each inspection of the registers."

***Amendment of Rule 5***

5. Rule 5 is amended by replacing it with the following new Rule 5 -

***"Form of Application (First Schedule).***

5. (1) The form of application for -

- (a) a licence to practice as a medical or dental practitioner;
- (b) registration as a medical or dental practitioner;
- (c) registration of additional qualification under section 13 of the Act;
- (d) provisional registration as a medical intern under section 16 of the Act;

- (e) restoration to the register, or
- (f) a duplicate copy of a certificate of registration or licence;

shall be in the appropriate form set out in Part I of the First Schedule.

(2) An application in terms of Rule 5(1) shall be supported by a character reference in the appropriate form set out in Part II of the First Schedule.

***Amendment of Rule 7.***

6. Rule 7 is amended by replacing it with the following new Rule 7 -

***“Penalty for false declaration***

7. A person who -

- (a) in an application for -
  - (i) registration as a registered or licensed medical or dental practitioner;
  - (ii) provisional registration under section 16 of the Act.
  - (iii) restoration of additional qualifications under section 13(1)(g) of the Act; or
  - (iv) restoration to a register;

makes a declaration knowing that it is false; or

- (b) willfully suppresses any relevant information which is called for in any of the forms contained in the First Schedule.

commits an offence and is liable, on conviction, to a fine of five hundred Emalangeni (E500.00) for each false declaration or suppression of relevant information.”

***Amendment of Rule 9.***

7. Rule 9 is amended by deleting it in its entirety.

***Revocation of Legal Notice No. 32 of 1998.***

8. Legal Notice No. 32 of 1998 is revoked.
