INCOME TAX; A DIRECTIVE TO ALL PERSONS MAKING PAYMENTS TO
RESIDENT CONTRACTORS AND TO PERSONS SUPPLYING GOODS OR
SERVICES TO THE GOVERNMENT OR PARASTATALS

In exercise of the powers conferred by section 59B of the Income Tax Order 1975, as amended, the Commissioner of Taxes hereby issues the following directive -

Citation and Commencement

1. This directive may be cited as the withholding of tax on payments to resident contractors or subcontractors and to persons supplying goods or services to the Government or parastatals directive, 2005 and shall come into effect on 1 November 2005.

Requirements of the law

2. Note that in terms of section 59B of the Order, if the Commissioner has reason to believe that any tax payable may not be recovered the Commissioner may issue a directive to any person to withhold tax from any money which -

- (a) is due or may become due to the person liable to taxation;
- (b) the person holds or may subsequently hold for or on account of the person liable to taxation;
- (c) the person has authority from another to pay to the person liable to taxation.

3. The rate of tax to be withheld under this directive is 10% of the amount stated in subparagraphs (a), (b), and (c) above. The withholding is on account of the liability to tax of the person liable to tax.

Definition of Contractor

4. In this directive -

“contractor” means a person who is in the business of providing leasing, construction, transportation or any other service under a contract where the primary purpose of the contract is the performance of service.

Directive to withhold tax on payments to resident contractors or persons supplying goods and services to the government or a parastatal

TAKE NOTICE that every person, who -

- (i) contracts with a resident contractor or subcontractor; or
- (ii) contracts with a resident person for the performance of services in relation to construction operations performed in Swaziland,

is required to deduct or withhold tax at the rate of 10% of the gross amount payable to the resident contractor or subcontractor during the 2005/2006 year of assessment, and each succeeding year of assessment thereafter.

This directive does not apply to payments by an individual relating to the erection or improvement of the individual's principal residence.

- (iii) where the Government or a parastatal contracts with a resident person for the provision of goods or services, the Government or parastatal shall withhold tax at the rate of 10% of the gross amount payable to such persons.

Exemption certificate

This withholding tax shall not apply to any person (the payee) who produces an exemption certificate from the Commissioner that he has complied with the following statutory obligations in any year of assessment -

- (a) That the person concerned has rendered all the required returns of income in respect of each year of assessment in question;
- (b) That all provisional tax payments in respect of any year of assessment have been fully paid;
- (c) That any duly assessed tax in respect of any year of assessment has been fully paid;
- (d) That all remittances as regards PAYE and other withholding taxes have been made.

The exemption certificate will be issued on request in respect of each year of assessment.

AND FURTHER TAKE NOTICE that the person required to comply with this directive must, in terms of section 37, furnish to the Commissioner a return showing the payments made to any person subject to this directive in any year of assessment, and furnish, to the person to whom payment of any amount is made, a certificate showing the amount of the tax withheld during the year of assessment.

The certificate must include the full name and address of such persons, and where the person is a natural person, the Personal Identification Number (PIN) of such person or, in the case of any other person, the tax number.

The tax withheld under this directive must be remitted to the Commissioner within fifteen days from the date of payment.

Object of the directive

The object of this directive is to -

- 1. Encourage voluntary compliance;
- 2. Detect and correct non-compliance;
- 3. Bring to charge all taxpayers having an income; and
- 4. Enforce the collection of all outstanding taxes.

EXPLANATORY NOTE

TAX DIRECTIVE: WITHHOLDING TAX ON PAYMENTS TO RESIDENT PERSONS

As regards paragraphs (i) and (ii)

1. This directive provides for withholding of tax at source from payments to independent contractors resident in Swaziland. In accordance with this directive, a person who contracts with a resident contractor is required to withhold tax at the rate of 10% of the gross amount of any payment made to the contractor under the contract. The obligation continues until the contract is complete.

2. The obligation to withhold is imposed on every "person" who makes a payment to a resident contractor. "Person" for this purpose has the meaning in section 2 of the Order, and therefore, the obligation to withhold applies to an individual, partnership, company, government or local authority etc. The obligation to withhold, however, does not apply to payments made by an individual for the erection or improvement of the individual's principal residence. This is intended to prevent the obligations of this directive falling on ordinary householders.

3. For the directive to apply, the payment must be made to a "resident contractor". The term contractor is defined to mean a person who is in the business of providing leasing, construction, transportation or any other service under a contract where the primary purpose of the contract is the performance of service. By virtue of the definition of "person", an individual, partnership, company, government or local authority etc may be a contractor. The requirement that the person be in the "business" of providing the relevant services is intended to exclude employees from the definition of contractor.

4. The fact that goods are also provided under the contract for service does not itself preclude a person from being a contractor, provided the provision of goods is ancillary to the provision of services. For example, while a builder in the construction industry will provide materials for the erection of a building, the primary purpose of a person who contracts with the builder is to obtain the builder's services and not the goods which the builder supplies. In the ordinary course, therefore, a builder will be a contractor.

On the other hand, the supplier of materials to the builder ordinarily will not be a contractor even if the supplier transports the materials to the building site, the primary purpose of the contract being the supply of goods rather than transportation services. If the supplier of material contracts with a person to transport the materials to the building site, then that person will be a contractor being the provider of transportation services.

5. The amount of tax to be withheld is 10% of the gross payment made under the contract, including the cost of any materials supplied by the contractor. The tax withheld is set off against the contractor's final liability for the year of assessment.

Directive to withhold tax on payments to resident persons supplying goods and services to the government or a parastatal

6. Notwithstanding that the scope of paragraphs (i) and (ii) covers contracts entered with the Government and parastatals and that the directive primarily refers to the supplying of services by resident contractors, paragraph (iii) ensures that payments to residents, who supply goods, equipment etc to the Government or parastatals do come within the purview of this directive.

3. (1) The Commission shall investigate and inquire into the activities of the office of the Secretary to the Board in carrying out its mandate, whether or not it has conducted itself in terms of practice, regulations and in terms of the law.

(2) Without derogating from sub section (1) the Commission shall investigate and inquire whether there is any inappropriate or unlawfulness in -

- (a) the issuance or in the manner of issuance of certain transport licenses including licenses with reference numbers 16426, 17043, 14047 and 10464;
- (b) the relationship that exists between the office of the Secretary to the Board and the clerical office and the members of transport operators;
- (c) the manner the office work was carried out, more especially whether or not all transactions were carried out in offices not known by Government; and
- (d) whether licenses issued or amended are done with the authority of the Board.

(3) The Commission shall further -

- (a) call for the production of any documents as the Commission may deem necessary and relevant to this enquiry;
- (b) investigate and recommend on means of improving the operations and issuing road transport permits; and
- (c) summon any witness to attend and give evidence before the Commission.

Submission of Report

4. (1) The Commission shall, after making appropriate findings, submit a report containing appropriate recommendations on any matter which is the subject of the enquiry including recommendations regarding the taking of any criminal or civil action against any person to the Minister.

(2) The Commission shall present its final report to the Minister not later than four weeks from the start of its work or on such other later date as the Minister may determine.

Venue

5. The enquiry shall be held at such places and times, as the chairman shall determine.

Allowances

6. The members of the Commission shall be paid such allowances as the Minister may determine.
