# THE APPROPRIATION BILL, 2006

(Bill No. 1 of 2006 (To be presented by the Minister of Finance)

### MEMORANDUM OF OBJECTS AND REASONS

The object of this Bill to charge the Consolidated Fund with the sum of Six billion, four hundred and sixty one million, seven hundred and twelve thousand Emalangeni (6,461,712) for the period commencing on the 1<sup>st</sup> April, 2006 ending on the 31<sup>st</sup> March, 2007.

# A BILL entitled

AN ACT to provide for the appropriation of a certain sum of money for the financial year commencing on the 1<sup>st</sup> April, 2006 and ending 31<sup>st</sup> March, 2007.

**ENACTED** by the King and Parliament of Swaziland.

# Short title and commencement

1. This Act may be cited as the Appropriation Act 2006 and shall come into force on the 1<sup>st</sup> April, 2006.

# Charge to Consolidated Fund

2. The Consolidated Fund is charged with sum of money not exceeding Six billion, four hundred and sixty one million, seven hundred and twelve thousand Emalangeni (6,461,712) in the aggregate as required for the services of the Government of the Kingdom of Swaziland during the financial year commencing on the 1st April, 2006 and ending on the 31st March, 2007.

# Application of sum appropriated

3. The sum appropriated by Section 2 shall be applied to the services set out in the first column of the Schedule and in the respective amounts appearing in the second and third columns in respect of each service.
