The rates become due and payable on the 31st May 2007 and rates bills (assessments) shall be mailed to property owners before this date.

Section 30 of the Rating Act provides for a penalty of 15% per annum to be charged for each month or part of a month on rates remaining unpaid after the expiry of two (2) months from the date on which the rates become due and payable.

Payment by Instalments

The Act permits payment by instalment. Ratepayers who wish to take advantage of this facility must contact the Rating Section as soon as they receive their rate notices.
Ratepayers are also reminded to use the Swaziland Building Society facility.

No request to enter into an agreement for instalment payment shall be entertained after the 30th June 2007.

Notification of Addresses

The attention of all property owners in the urban area of Mbabane is drawn to Section 37(4) and (5) of the Rating Act which reads as follows:
