## LEGAL NOTICE NO. 8 OF 2008

### THE COMMISSION OF ENQUIRY ACT 1963 (Act No. 35 of 1963)

#### THE APPOINTMENT OF THE NATIONAL AGRICULTURE SUMMIT PROJECTS DEVELOPMENT TASK FORCE NOTICE 2008 (Under Section 3)

In exercise of the powers conferred by Section 3 of the Commissions of Enquiry Act 1963 the Minister of Agriculture and Cooperatives issues the following Notice -

#### *Citation and Commencement*

1. This Notice may be cited as the Appointment of the National Agriculture Summit Projects Development Task Force and shall be deemed to have come into force on the 1<sup>st</sup> October, 2007.

#### *Establishment and Appointment of Members of the Task Force*

2. (1) There is hereby established a committee to be known as the National Agriculture Summit Projects Development Task Force (hereinafter referred to as "the Task Force).

- (2) The Task Force shall be composed of the following members -

#### *Functions of the Task Force*

3. (1) The Task Force shall -
  - (a) Develop fundable and bankable project and programmes from the Action Plan of the National Agriculture Summit, outlining discrete implementation strategies.
  - (b) Cost the identified projects and programmes.



- (c) Determine time frame for the identified projects and programmes.
  - (d) Develop implementation schedule for identified projects and programmes.
  - (e) Review existing project proposals and associated documents on policies, programmes, and strategies.
  - (f) Integrate existing policies, programmes, projects and strategies into the Summit Agenda for Action.
- (2) The Task Force shall produce and deliver to the Minister a report based on the operation of this Notice. The report shall consist of the National Agriculture Summit Agenda for Action, which will be clustered into the following time bound interventions.
- (a) Short term interventions,
  - (b) Medium term interventions and,
  - (c) Long term interventions.

***Submission of Report***

4. The Task Force shall no later than 1<sup>st</sup> December 2007 submit the report mentioned in Section 3 (2) to the Minister.

***Allowances and reimbursements***

5. The members of the Task Force shall be entitled to sitting allowances and, where applicable, reimbursements for travelling expenses in accordance with the Finance Circular No. 4 of 1998.

***Extension of time***

6. The Minister with the Cabinet approval may, by Notice published in the Gazette, extend the time specified under section 4.
