## LEGAL NOTICE NO. 79 OF 2008

### THE COMMISSIONS OF INQUIRY ACT, 1963 (Act No. 35 of 1963)

### THE 40<sup>TH</sup> NATIONAL DOUBLE CELEBRATIONS TASK TEAM NOTICE, 2008 (Under Section 3)

In exercise of the powers conferred by Section 3 of the Commission of Enquiry Act, 1963, the Minister issues the following Notice;

#### ***Citation and Commencement***

1. (1) This Notice may be cited as the 40<sup>th</sup> National Double Celebrations Task Team, Notice, 2008.

(2) The Notice shall be deemed to have come into force on the 29<sup>th</sup> October, 2007.

#### ***Establishment of the Task Team***

2. There is hereby established a Task Force to be known as the 40<sup>th</sup> National Double Celebrations Task Force (hereinafter referred to as "the Task Team"). The team shall report to a Cabinet sub-committee on the 40<sup>th</sup> National Double Celebrations.

#### ***Objects and Purposes of the Task Team***

3. (1) The Task Force shall be responsible for the preparation of a program of activities to be carried out in preparations of the double celebrations.

(2) Without derogating from sub-section (1) the Task Force shall:-

- (a) prepare the budget for the celebrations;
- (b) appoint in consultation with the Cabinet sub-committee and sub-committees as may be required for the smooth preparations of the celebrations;
- (c) co-ordinate the activities of the various sub-committees to be appointed;
- (d) act as a resource and information center for people connected with the celebrations;
- (e) handle correspondence and distribution of invitation card;
- (f) ensure that decisions of Cabinet sub-committees are implemented;
- (g) prepare regular reports to the Cabinet sub-committee;
- (h) open a special account with a commercial bank for the daily operations;
- (i) determine human resource requirements for service delivery during the celebrations;

(3) The Task Team shall meet at least twice a month.

(4) The Task Team may, with the consent of the Cabinet sub-committee sit more that twice a month.

(5) The Task Team shall prepare comprehensive financial report that will be audited by an independent audit firm immediately after the end of the celebrations.

***Composition of the Task Committee***

4. The Task Team shall comprise of the following members:-

***Duration of the Task Team***

5. (1) The Task Force shall deliver a comprehensive project completion report to the Cabinet sub-committee within 30 working days after the celebrations.

(2) The Minister may extend the date on which the Task Team will submit the comprehensive project completion report.

- (a) Make and co-ordinate preparations for the Independence and King's Birthday Celebration in the year 2007.

***Remuneration of Members of the Task Team***

6. The members listed under (c) up until (z) shall be entitled to such allowance and, where applicable, reimbursement for travelling expenses in accordance with Finance Regulations and Circulars that may from time to time be implemented or as a Minister may sometimes determine.

7. The Chairman and Executive Secretary listed under (a) and (b) respectively shall be paid according to their terms and conditions as the Minister for Home Affairs and Minister for Finance may determine.
