THE APPOINTMENT OF MEMBERS OF THE DAIRY BOARD  
NOTICE, 2010  
(Under Section 4)

In exercise of the powers conferred by Section 4 of the Dairy Act 28, 1968, the Minister of Agriculture issues the following Notice -

***Citation and Commencement***

1. (1) This Notice may be cited as the Appointment of Members of the Dairy Board Notice, 2010.

(2) This Notice shall be deemed to have come into force on the 1<sup>st</sup> November, 2010.

***Appointment of Dairy Board Members***

2. (1) The following persons are appointed as members of the Dairy Board with effect from 1<sup>st</sup> November, 2010.

(2) The members are appointed for a period not exceeding three years.

***Functions of the Board***

3. The Board shall perform the functions as assigned to it under the Dairy Act, 1968 and the Public Enterprises Act, 1989.

***Allowances***

4. The members of the Board shall be entitled to such allowances and, where applicable, reimbursement for travelling expenses in accordance with the applicable Finance Circular.

5. Legal Notice No. 185 of 2007 is revoked.
