Citation and Commencement

1. (1) This Notice may be cited as the appointment of a Task Team to Draft Regulations for the Road Transportation Passenger Liability Cover, Notice 2011.

(2) This Notice shall come into force on the date of publication in the gazette.

2. (1) A Task Team to draft regulations on Road Transportation Passenger Liability Cover is established.

Terms of reference of the Task Team

3. The Task Team shall research and draft regulations for road transportation passenger liability cover as enjoined by section 20 (1) (c) read with section 36 of the Road Transportation Act, 2007.

Terms of office

4. The Task Team shall carry out its functions for a period of three weeks from the date of publication of this notice.

Extension of time

5. The Minister may, in consultation with the Chairman, extend the term of office of the task team.

Payment of Allowances

6. The Task Team shall be entitled to such allowances and, where applicable, re-imbursement for travelling expenses in accordance with the applicable Finance Circular.
