THE CONSTITUTION OF SWAZILAND ACT, 2005

THE PRESCRIPTION OF STATUTORY SALARIES AND ALLOWANCES  
OF COMMISSIONS AND BOARDS NOTICE, 2011  
(Under Section 208)

In exercise of the powers conferred by 208 of the Constitution of Swaziland, 2005, the Minister of Finance hereby issues the following Notice -

***Citation and Commencement***

1. This notice may be cited as the Prescription of Statutory Salaries and Allowances of Commissions and Boards Notice, 2011, and shall be deemed to have come into force on the 1<sup>st</sup> May, 2011.

***Prescription of salaries and allowances***

2. Without prejudice to any other benefits conferred by any law, the holder of an office specified in the first column of the Schedule shall be paid not less than the salary or allowance or both (as the case may be) specified in relation to the holder, in the second, third, fourth, fifth, sixth, seventh and eighth columns of the Schedule.
