## LEGAL NOTICE NO. 73 OF 2011

### THE COMMISSIONS OF ENQUIRY ACT, 1963 (Act No. 35 of 1963)

#### THE APPOINTMENT OF THE KING'S CUP GOLF TOURNAMENT TASK TEAM NOTICE, 2011 (Under Section 3)

In exercise of the powers conferred by section 3 and 5 of the Commissions of Enquiry Act, 1963, the Minister for Tourism and Environmental Affairs issues the following notice -

#### *Citation and Commencement*

1. (1) This Notice may be cited as the Appointment of the King's Cup Golf Tournament Task Team Notice, 2011.

(2) This Notice shall be deemed to have come into force on 27<sup>th</sup> April, 2011.

#### *Establishment of the Task Team*

2. There is hereby established a Task Team to be known as the King's Cup Golf Tournament (hereinafter referred to as the Task Team).

#### *Appointment of members of the Task Team*

3. The following people whose names appear below are appointed as members of the Task Team -

***Quorum***

4. The quorum of the Task Team shall be six members including the chairperson.

***Functions of the Task Team***

5. The Task Team shall be responsible for -

- (a) the overall management of the King's Cup Golf Tournament 2011;
- (b) organizing dates and venues for the event in consultation with the relevant stakeholder;
- (c) scouting for funding and sponsorship for the event;
- (d) co-opting expertise where necessary;
- (e) liaising with other local or foreign professional and amateur golfers associations on the logistics of the King's Cup; and
- (f) any other matter incidental to the King's Cup Tournament.

***Meeting of the Task Team***

6. The Task Team shall meet at the Ministry of Tourism and Environmental Affairs or such other place and time as the chairperson may determine.

***Duration***

7. (1) The term of office of the Task Team shall be with effect from 27<sup>th</sup> April, 2011 to 31<sup>st</sup> December, 2011.

- (2) The Minister may extend or terminate the term of office of the Task Team.

***Reporting***

8. (1) The Task Team shall periodically give the Minister a progress report on the preparations of the tournament.

- (2) The Task Team shall submit its final report on or before 31<sup>st</sup> December, 2011.

***Remuneration***

9. Members of the Task Team shall be paid such allowances as the Minister may determine after consultation with the minister for Finance.
