THE PRICE CONTROL ORDER, 1973 (Order No. 25 of 1973)

THE MAXIMUM WHOLESALE AND RETAIL PRICES OF PETROLEUM PRODUCTS NOTICE, 2012 (Under Section 5 & 10)

In exercise of the powers conferred by Section 5 and 10 of the Price Control Order, 1973 the Price Controller issues the following Notice.

Citation and Commencement

1. This Notice may be cited as the Maximum Wholesale and Retail Prices of Petroleum Products Notice, Tuesday 10th January 2012 and shall be deemed to have come into force at midnight on the 10th January 2012.

Maximum Prices and Petroleum Products

2. (1) Subject to Section 2 (2), the Maximum Wholesale and Retail Prices of Petroleum Products shall be as set out in the Schedule to this Notice.

(2) Maximum Wholesale and Retail Prices of Petroleum Products as set out in the Schedule shall be subject to the condition that no oil company shall grant or allow a rebate or discount to any customer without first obtaining the consent of the Price Controller.

Revocation of Legal Notice No. 183 of 2011

3. Legal Notice No. 195 of 2011 is revoked.
