OF THE SUPERIOR COURTS NOTICE, 2012
(Under Section 208)**

In exercise of the powers conferred by Section 208 of the Constitution of Swaziland Act, 2005, the Minister for Finance issues the following Notice -

Prescription of Salaries and Allowances

2. Without prejudice to any other benefits conferred by any law, the holder of an office specified in the first column of the Schedule shall be paid not less than the salary or allowance or both (as the case may be) specified in relation to the holder, in the second, third, fourth, fifth, sixth, seventh, eighth, ninth and tenth columns of the Schedule.
