THE COMMISSIONS OF ENQUIRY ACT, 1963 (Act No. 35 of 1963)

APPOINTMENT OF THE SCHOLARSHIP SELECTION BOARD NOTICE, 2013 (Under Section 3)

In exercise of the powers conferred by Section 3 of the Commissions of Enquiry Act, 1963 the Minister for Labour and Social Security hereby issues the following Notice-

Citation and Commencement

1. This Notice may be cited as the Appointment of the Scholarship Selection Board Notice, 2013 and shall be deemed to have come into force on the 1st July 2013.

Appointment of Committee

2. (i) There is hereby appointed a Board to be known as the Scholarship Selection Board (hereinafter referred to as the Board).

(ii) Any member may act as the deputy chairperson in the absence of the substantive chairperson.

(iii) The Board shall consist of the following members-

Functions of the Board

3. The Board shall perform the following functions:
- (a) Select and approve suitable candidates for the award of scholarships granted by or through the Government for pre-service training;
 - (b) Advise the Minister on matters relating to scholarships; and
 - (c) Perform such other functions relating to scholarships as may be determined by the Minister.

Term of Office

4. The Board is appointed for a period not exceeding three (3) years, with effect from the 1st July 2013.

Meetings and Quorum

5. The Board shall hold meetings at such place and time, as the members may determine. Six members including the Chairperson shall constitute a quorum.

Allowances and Fees

6. The members of the Board shall be entitled to such allowances and, where applicable, reimbursement for travelling expenses in accordance with Finance circular No. 2 of 2005 or other subsequent circulars that may be issued from time to time.
