THE ROYAL EMOLUMENTS AND CIVIL LIST (AMENDMENT) ACT, 2013

(Act No. 12 of 2013

AN ACT ENTITLED

AN ACT to amend the Royal Emoluments and Civil List Act, 1992, and to provide for matters incidental thereto.

ENACTED by the King and the Parliament of Swaziland

Short title and commencement

1. This Act may be cited as the Royal Emoluments and Civil List (Amendment) Act, 2013, shall be read as one with the Royal Emoluments and Civil List Act, 1992 (hereinafter referred to as the "Principal Act") and shall come into force on the date of publication in the Gazette.

Amendment of Section 3

- 2. (1) Section 3 of the Principal Act is hereby amended-
 - (a) by replacing subsection (I) thereof with the following new subsection (1)-
 - "(1) There shall be paid in advance for the Royal Emoluments and Civil list set out in Parts I and II of the Schedule such amount as Parliament may approve on a yearly basis and the Minster shall cause the yearly amount to be published in the Gazette.";
 - (b) in subsection (9) thereof by deleting the word "the" which appears between the words "of' and "five";
 - (c) by replacing subsection (10) thereof with the following new subsection 10 -
 - "(10) Where there is an adjustment in the remuneration of civil servants -
 - (a) such adjustment shall also be effected in the salaries of the personnel in the King's office;
 - (b) the yearly sum provided for under subsection (2) shall be adjusted accordingly; and,

- (c) the Minister shall, by Notice published in the Gazette, notify of such change."
- (d) by replacing subsection (11) thereof with the following new subsection 11-
 - "(11) The Minister may apply for supplementary funds at any time where there is a shortfall in the sum allocated under subsection (3)."

Amendment of Section 4

3. Section 4 of the Principal Act is hereby replaced with the following new section 4:

"Royal Trustees

- 4. (1) The Minister, and not more than four other persons of distinction appointed by the King, shall constitute the Royal Trustees for the purposes of this Act, and any act of the Trustees shall be signified under their respective hands and official seals.
- (2) The four (4) members of the Royal Trustees shall hold office for a period not exceeding five (5) years which may be renewed and on such terms and conditions (including allowances) as the King may determine in consultation with the Minister.
- (3) The Royal Trustees shall meet for the conduct of their business at least once in every three months and at such other times as the King may from time to time direct.
 - (4) The Minister shall convene and chair meetings of the Royal Trustees.
- (5) Subject to the provisions of this Act, the Royal Trustees shall monitor and control the Civil List expenditure.
 - (6) For the discharge of their duties under this Act, the Royal Trustees-
 - (a) shall have access to all books, records, returns and other documents relating to the Civil List expenditure; and,
 - (b) may request such information relating to the Civil List expenditure as they deem necessary."

Deletion of section 6

4. Section 6 of the Principal Act is hereby deleted.

Amendment of section 9

5. Section 9 of the Principal Act is hereby amended in subsection (1) thereof by replacing the figure "15" with the figure "14".

Amendment of Section 10

- 6. Section 10 of the Principal Act is hereby amended-
 - (a) in subsection (1) thereof by replacing the figure "15" with the figure "14"; and,

- (b) by replacing subsections (2) and (3) thereof with the following new subsections (2), (3) and (4):
 - "(2) The Chief Officer shall perform the functions of Secretary to the Royal Trustees.
 - (3) The Chief Officer shall, in addition to such functions as may be prescribed by this Act or regulations under section 14, generally co-ordinate and manage the business of the Royal Household on behalf of the King.
 - (4) The Chief Officer shall be assisted in the performance of his or her functions under this Act by such staff as may be appointed under section 1 0."

Amendment of Section 11

- 7. Section 11 of the Principal Act is hereby amended -
 - (a) in subsection (2) thereof by replacing the figure "15" with the figure "14"; and,
 - (b) in subsection (3) thereof by replacing the figure "15" with the figure "14".

Amendment of Section 12

- 8. Section 12 of the Principal Act is hereby amended-
 - (a) in subsection (1) thereof by replacing the figure "15" with the figure "14"; and,
 - (b) in subsection (2) thereof by replacing the figure "15" with the figure "14"

Renumbering of Section 7 through to 16

9. Sections 7 to 16 of the Principal Act are hereby renumbered as 6 to 15.

Replacement of the Schedule

10. The Schedule to the Principal Act is hereby replaced with the following new Schedule -

SCHEDULE

PART I ROYAL EMOLUMENTS

Royal emoluments and related payments to such immediate members of the Royal Household as the King may from time to time determine.

PART II CIVIL LIST EXPENDITURE

Class I - Salaries and other related personnel costs of staff employed in the King's Office and in the Palaces, Royal Residences, State Houses and Guest Houses.

Class II - The expenses including the costs of routine daily maintenance of the King's Office and the Palaces, Royal Residences, State Houses and Guests Houses.

PART III MISCELLANEOUS EXPENSES OF ROYAL HOUSEHOLD

- Major maintenance of the King's Office, Palaces, Royal Residences, State and Guest Houses.
- 2. State functions.
- 3. State visits.
- 4. Maintenance and running costs of fleet of vehicles of the Royal Household.
