THE APPOINTMENT OF MEMBERS OF THE COMPETITION

In exercise of the powers conferred by Section 8 of the Competition Act, 2007, the Minister for Enterprise and Employment, hereby issue the following Notice.

### *Citation and Commencement*

1. This Notice may be cited as the Appointment of Members of the Competition Commission Notice, 2008 and shall come into force on the date of publication.

### *Appointment of Commission*
